### **1. Ordinance Amendment- Licensee to Close at Certain Times**

The Liquor Ordinance Ad Hoc Committee met to discuss various concerns regarding the current liquor ordinance. Attached is a proposed ordinance amendment regarding [closing times](#) for licensed establishments. A proposed ordinance was discussed during last month's Liquor and Gambling Control Committee and died in Committee. A new proposal is attached for consideration.

It is recommended the Committee and Council adopt the proposed changes to the City of Minot Code of Ordinances.

### **2. Ordinance Amendment- Limitation on the Number of Retail Liquor Licenses**

The Liquor Ordinance Ad Hoc Committee met to discuss various concerns regarding the current liquor ordinance. Attached is a proposed ordinance amendment regarding the [limitation on the number of retail liquor licenses](#). This ordinance was discussed last month and it was held so the City Attorney could draft an ordinance amendment.

It is recommended the Committee and Council adopt the proposed changes to the City of Minot Code of Ordinances.

### **3. Gaming Site Extension – Grand Hotel, Convention Center – MSU Alumni Association**

The City has received a request from MSU Alumni Association for an extension of their site authorization to include the Convention Center at the Grand Hotel, 1505 North Broadway for a Banquet on April 5, 2017.

It is recommended the Committee and Council grant a gaming site authorization extension of premises for MSU Alumni Association at the Grand Hotel on April 5, 2017 for a special event.
