4. DISCUSSION OF METROPOLITAN TRANSPORTATION PLAN REQUEST FOR QUALIFICATIONS

5. STATUS UPDATE OF CDMPO TASKS

- MPO Contract – Work Program Contract after we have the signed UPWP and the Federal Highway has approved it.
- Roadway Functional Class update was done by Dana Larsen and Lance Meyer.
- Public Participation Plan – Executive Director Position will help to put this plan into place.
- Transportation Improvement Plan – Due by the end of 2026.
- Internal Policies and Procedures – Executive Director Position will create these.
- MTP – Discussed the RFP
- Website – Johnson proposed considering this in the RFP. The city may be providing the landing page.
- When minutes are finalized they will be posted for members to download
- Sam.gov – Waiting to hear back once it is finalized

- MPO Insurance – Mentioned at the last policy board meeting. Johnson encouraged members to look into this.
